## DATA, ASSURANCE AND INSIGHTS COMMUNITY OF PRACTICE

The Data, Insights and Assurance Community of Practice (DAICOP) held its first session this month. This group aims to share the data, assurance and insights work being done within the sector and provides an opportunity to connect with experts. Those who will benefit most from attending will be H&S practitioners who are collecting, assessing, analysing and presenting health, safety and wellbeing information, and Data Analysts who are supporting the health and safety function. This first session was attended by 25 people. At the meeting, MPI shared their governance dashboards, a draft deep-dive framework was presented and the session ended with a brief review of an academic report on the statistical invalidity of TRIR as a measure of safety performance.

# SUCCESS FOR OUR 2023 EARLY IN CAREERS HEALTH AND SAFETY CERTIFICATE

Our first "Public Sector Early in Careers Health and Safety Certificate" programme concluded on 8 November 2023, and I am thrilled to announce that 21 out of 23 attendees completed and passed their Level 3 NZQA Early in Careers Certificate.

This new Certificate is a steppingstone programme, providing an introduction to the pathway of what a 'good' H&S advisor looks like, as outlined in the <u>H&S Generalist Career Pathway</u>. It uses NZQA's microcredentialling qualification process to help build the required vocational knowledge, which when combined with on-the-job experience, helps to deliver the overall skills that are required by employers and the H&S industry.

# SAFEGUARD STATE OF THE NATION SURVEY

## **FAREWELL OUR SUMMER INTERNS**

This month we said goodbye to the seventh cohort of GHSL Summer Interns, 19 of whom completed their three-month placement across 16 public sector agencies located in Auckland and Wellington. At the farewell event, the interns reflected on their experiences, presented their completed work and talked about their appreciation for how their agencies supported them in their first roles. The interns have been engaged in a diverse range of projects including Wellbeing initiatives, Critical H&S Risks, Data insights, H&S assurance, Capability building and Learning reviews and incident investigations.

We also celebrated a significant milestone this year, with the latest cohort taking the number of interns who have taken part in the programme up to 102 interns from 30 public sector agencies. The long term benefits of this programme are starting to come through, with around half of all previous interns now working in advisor and senior advisor roles across the sector.
