EARLY IN CAREERS PROGRAMME

We're excited that our Early in careers programme is on track to be microcredentialed later this year, giving more weight to the programme and the benefits it has. The programme is targeted towards people new to their Health and Safety role, such as H&S co-ordinators or H&S advisers, and has proved incredibly popular with participants. The programme this year will be run in the second half of 2023 – costs remain steady at \$1,165+GST per attendee, so you may want to ensure some funding is included in your 2023/24 budget. <u>Contact Debbie</u> for more information.





SUMMER INTERNSHIP PROGRAMME

Twelve agencies participated in the sixth GHSL Summer Internship Programme this year with two interns placed in Auckland, and the rest located in Wellington. They have undertaken a range of projects for their agencies, as well as activities within the cohort, which included meeting with Hon. Michael Wood, Minister for Workplace Relations and Safety, and WorkSafe Chief Executive, Phil Parkes.

A highlight was the Learning Day at Wellington Zoo. The day at the Zoo provided unique insights into the identification and management of the critical risks they face. Four of our interns have already gained employment in the public sector and two are returning to study. The remaining six are looking for ongoing work in the H&S area, so if you have any entry level vacancies, please reach out for contact details.

The intern programme has a success rate of securing employment for 50% of our interns in a part-time or full-time capacity, meeting our objective of supporting the next generation into work in health and safety across the public sector. With your continued support we hope to continue to inspire more new graduates to seek out roles in health and safety roles across New Zealand.

We have been working with WorkSafe, PSA, H&S Reps, H&S practitioners and leaders and others across the sector to develop guidance on the H&S Rep role. The guidance outlines key things for H&S Reps, their manager, and the wider organisation to consider and what the role entails. Thank you to all who contributed to the guidance. MENTALLY HEALTHY WORK PROGRAMME

Our first practitioners' Mentally Healthy Work Community of Practice (MHWCOP) took place in November last year. The MHWCOP will be held on the first Thursday of each month and will invite world-leading experts to share their knowledge. It also serves as an opportunity for agencies to share their initiatives and ask questions of each other in this space. Our next MHWCOP is on the 2nd of February – please reach out if your relevant team members aren't already invited to attend.

The next phase of the Mentally Healthy Work Development Programme is set to begin in March and expressions of interest are now open. The objective of the MHW Development Programme is to build core understanding of psychological health and safety. The programme has respective streams for:

- Chief Executives and Officers (we encourage tier 1 and leading tier 2 attend together)
- Heads of H&S / HR / OD
- Practitioners (H&S, HR and OD)

Places are limited and preference at the practitioner and Heads of levels will be given to agencies whose Chief Executives are confirmed on the CE component of the Programme. <u>Contact Millie</u> for more information or to register.





GHSL TEAM RESTRUCTURE
