### **GHSL MOBILE APP**

As the public service digitises systems to meet the needs of people in a changing world, through the support of the Ministry for Primary Industries, the GHSL is developing a mobile app solution to enable Officers and Executives to more easily meet their due diligence obligations. This app will include features to share news and updates, events, resources, recording site visits, learning records and complete self-assessments. The app will be publicly available on iOS and Android stores with some features only available to authenticated users. ## T2 HSW LEADERS - THIRD BREAKFAST HOSTED BY THE MINISTRY FOR THE ENVIRONMENT

Laura Dixon, Deputy Secretary Business Transformation and Services at MFE shared their experience and case study of managing an onsite psychological harm event. This was a respectful and thought-provoking session about how to manage the situation within the first hours and days of an event and understanding the long tail of the impact it can have on your workforce. The slides and summary notes will be shared shortly.

### TE TAUNAKI PUBLIC SERVICE CENSUS

The Public Service Commission has released the system and agency level results www.publicservice.govt.nz/census.

Overall, the results are encouraging and public servants have shared that they know that the work they do delivers real value to New Zealand and New Zealanders. Acting with integrity, maintaining transparency and upholding political neutrality are recognised as fundamental. They are motivated by a desire to make a positive difference for New Zealanders and are enthusiastic about their roles.

Despite these strengths, the Census has also revealed challenges that must be addressed. Public servants have said they face barriers including high workloads, unclear direction and objectives, insufficient tools and resources, and overly complex processes. A respectful workplace is not a universal experience. Many who do report unacceptable behaviour are not satisfied with how their agency handles these issues. There is a desire for more transparent and merit-based appointments, as well as a renewed effort to ensure our advice to ministers is free and frank.

As a next step, each agency is developing an action plan to address their key issues, which chief executives are responsible to act on.
