The Government Health and Safety Lead (GHSL) was formed in 2017 under the leadership of Ray Smith, then Chief Executive of the Department of Corrections. The GHSL moved to the Ministry of Primary Industries in 2019, following Ray Smith's appointment as Director-General.

The GHSL is a small team tasked with providing practical support to chief executives, senior leaders and the health and safety teams of government agencies to enhance their leadership of health and safety.

The GHSL works with over 40 public service agencies to:

- strengthen system capability.
- build cross-sector relationships that sustain learning and intelligence about what works.
- raise awareness of issues and opportunities.
- support sharing of proactive and joined up responses.
- develop resources to support the system, where it is practical to do so.
