2023/24 INTERNSHIP PROGRAMME UPDATE

The summer internship programme runs from 20 November to 16 February 2024 and the GHSL team has been working with our sector agencies to recruit top talent for their Health, Safety and Wellbeing summer intern positions. This year, we received an overwhelming response with 145 applications for the 18 positions available across 16 government agencies. On 6 September, we conducted 33 video interviews and selected 26 preferred candidates to proceed to the in-person interviews to identify the best candidates for our intern positions.

On 12 September, 18 candidates were selected to advance to the reference checking stage.

Next on the agenda is working on our intern programme of events for our successful interns to participate in, bringing a fresh perspective to our public sector view of Health, safety and wellbeing. 


MARITIME NZ JOINS THE GHSL
